The risks may include, but are not limited to, those caused by terrain, facilities, temperature, weather, lack of hydration, condition of participants, equipment, vehicle traffic and actions of others, including but not limited to, participants, volunteers, spectators, coaches, event officials and event monitors, and/or producers of the event.

I acknowledge that I have carefully read this "waiver and release" and fully understand that it is a release of liability. I expressly agree to release and discharge Tom's Creek Hunt Club, its Members and the Landowner and all of its affiliates, managers, members, agents, attorneys, staff, volunteers, heirs, representatives, predecessors, successors and assigns, from any and all claims or cause of action and I agree to voluntarily give up or waive any right that I otherwise have to bring a legal action against Tom's Creek Hunt Club, its Members and the Landowner for personal injury or property damage.

To the extent that the statute or case law does not prohibit release for negligence, this release is also for negligence on the part of Tom's Creek Hunt Club, its Members and the Landowner, its agent, and employees.

This agreement was entered into at arm's-length, without duress or coercion and is to be interpreted as an agreement between two parties of equal bargaining strength. Both the Participant, ______ and Tom's Creek Hunt Club, its Members and the Landowner agree that this Agreement is clear and unambiguous as to its terms, and that no other evidence will be used or admitted to alter or explain the terms of this Agreement, but that it will be interpreted based on the language in accordance with the purpose for which it is entered into.

In the event that any provision contained within this Release of Liability shall be deemed to be severable or invalid, or if any term, condition, phrase or portion of this Agreement shall be determined to be unlawful or otherwise unenforceable, the remainder of this Agreement shall remain in full force and effect, so long as the clause served does not affect the intent of the parties. If a court should find that any provision of this Agreement to be invalid or unenforceable, but that by limiting said provision it would become valid and enforceable, then said provision shall be deemed to be written, constructed and enforced as so limited.
